- 18. Registration is needed for the entry of two wheelers in the campus and four wheelers of the students are strictly prohibited.
- 19. The students shall keep away from the use of illicit drugs (narcotics), alcohol, tobacco etc. Which are strictly prohibited and punishable.
- 20. Mobile Phone, Camera, I pad etc. are strictly prohibited in the campus.
- 21. Ragging in any form and harassment of women are prohibited in the campus as per the orders of Government.

RULES FOR ADMISSION

- 1. Admission to PG and UG Courses are made by the University through Centralised Allotment Process except Management Quota. Applicants to all categories viz General, SC/ST, Management, Community Merit, Sports Quota, Cultural Quota, 'Physically Disabled should apply online.
- 2. Application for admission in the College under Community and Management quota seats should be made in the prescribed form which can be held from the Principal on payment of Rs. 50/- (Rs. 85/-by post) as Registration Fee, which is not refundable. Separate application should be submitted for management quota seats.
- 3 The registration number and the application number must be quoted in all subsequent correspondence.
- 4. The application for Degree/PG Course duly filled in should reach the College Office on or before the last date published on the College Notice Board as prescribed by the University.
- 5. Application containing false information will be rejected.
- 6. Candidates who are prepared to choose either Hindi or Malayalam as additional language alone will be selected for UG admission.
- 7. Students who are found eligible for admission will be called for the interview for which they should appear, accompanied by their parent or guardian.
- 8. All columns in the application must be carefully filled in. Attestation of marks should be done in the appropriate pages. Non compliance with the same will entail rejection of the application.
- 9. Applicants are advised to keep with them sufficient true copies of their certificates before they produce the original certificates to the College Office on admission.
- 10. Eligibility of SC/ST/ OEC /OBC/OBC(H) Fishermen students for fee-concession is subject to the orders of the Government, even if selected under centralized allotment| process. After obtaining admisssion the students must produce application form registered via Akshaya Kendra, Income & Caste Certificate (In original), Allotment Memo, copy of Adhar

- card, Bank pass book, SSLC, +2, Degree, as in the case may be. In the case of fishermen student Form No. 4 certifificate issued by the Fisheries Department concerned duly signed by the fisheries officer concerned and copy of valid fishermen registration certificate should be produced for availing the fisherman scholarship.
- 11. (a) Students are eligible for full fee concession provided the annual income for their parents or guardians does not exceed Rs. 1,00,000/- for Graduates and Rs. 3,00,000/- for Post Graduates. They will have to produce the income certificate in the prescribed by the concerned authority.
- (b) No income limit for SC/ST students.
- 12. S.C., S.T., O.E.C., O.B. (H), OBC and General students, once admitted on the community and income certificate, should remit all the fee dues for the term, if they discontinue their studies.
- 13. If the Government or University revises the semester or examination fee structure, the students shall pay the fees at the revised rate.
- 14. Documents to be produced at the time of interview.
- a) S.S.L.C. Book
- b) Original mark list of plus two or equivalent qualifying examinations.
- c) 5 Photostat copies of mark list of S.S.L.C. and Plus 2 or equivalent qualifying examination
- d) Transfer Certificate (Compulsory)
- e) Conduct Certificate from the Head of the Institutions last studied (6 months validity)
- f) Originals of Cast and Income certificates, 5 Passport Size photographs.
- g) Intimation card/University allotment memo
- h) Migration certificate in the case of students who have passed from any other University/Board outside state must be produced with a month after enrolment.
- 15. Remittance and Refund of Fees as per UGC / Govenment Norms
- 16. If any admission is found ineligible by the University later his/her admission shall be automatically cancelled.
- 17. Fee defaulters will not be registered for the university examinaion.
